2. IN PARAGRAPH 2 OF MESSAGE 0109313, THE DEPARTMENT INCORRECTLY INSTRUCTED CBP TO LIQUIDATE ALL ENTRIES FOR ALL FIRMS.
3. PARAGRAPH 2 OF MESSAGE 0109313 CURRENTLY READS AS FOLLOWS:

COMMERCE HAS NOT RECEIVED A REQUEST FOR AN ADMINISTRATIVE REVIEW OF THE ANTIDUMPING DUTY ORDER FOR THE PERIOD AND ON THE MERCHANDISE LISTED BELOW.
