1. ON 08/02/2010, COMMERCE PUBLISHED IN THE FEDERAL REGISTER (75 FR 45097) A NOTICE OF FINAL DETERMINATION IN THE ANTIDUMPING DUTY INVESTIGATION OF CERTAIN MAGNESIA CARBON BRICKS FROM MEXICO (A-201-837). THIS IS A CORRECTION OF PARAGRAPH 4 IN MESSAGE NUMBER 0225302, DATED 08/13/2010.

2. IN PARAGRAPH 4 OF MESSAGE NUMBER 0225302, THE EFFECTIVE DATE IS INCORRECT.

3. PARAGRAPH 4 OF MESSAGE NUMBER 0225302 CURRENTLY READS AS FOLLOWS:

FOR IMPORTS OF CERTAIN MAGNESIA CARBON BRICKS FROM MEXICO, CBP SHALL SUSPEND LIQUIDATION OF SUCH SHIPMENTS ENTERED OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION, ON OR AFTER 03/11/2010. EFFECTIVE 03/11/2010, CBP SHALL REQUIRE, FOR SUCH ENTRIES, A CASH DEPOSIT OR THE POSTING OF A BOND EQUAL TO THE MARGINS FOR THE PRODUCER AND/OR EXPORTER LISTED IN THE COMPANY-DETAILS TABLE APPENDED TO THE BOTTOM OF THIS MESSAGE.

4. INSTEAD, PARAGRAPH 4 OF MESSAGE NUMBER 0225302 SHOULD READ AS FOLLOWS:

FOR IMPORTS OF CERTAIN MAGNESIA CARBON BRICKS FROM MEXICO, CBP SHALL SUSPEND LIQUIDATION OF SUCH SHIPMENTS ENTERED OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION, ON OR AFTER 03/11/2010. EFFECTIVE 08/02/2010, CBP SHALL REQUIRE, FOR SUCH ENTRIES, A CASH DEPOSIT OR THE POSTING OF A BOND EQUAL TO THE MARGINS FOR THE PRODUCER AND/OR EXPORTER LISTED IN THE COMPANY-DETAILS TABLE APPENDED TO THE BOTTOM OF THIS MESSAGE.
