1. ON 09/21/2010, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON CERTAIN FROZEN WARMWATER SHRIMP FROM THE PRC A-570-893, FOR THE PERIOD 02/01/2008 THROUGH 01/31/2009. THIS IS A CORRECTION OF PARAGRAPH 6 IN MESSAGE 0267307, DATED 09/24/2010.

2. IN PARAGRAPH 6 OF MESSAGE 0267307, THE DEPARTMENT INCORRECTLY STATED THAT THE APO DOCKET CENTER WAS SERVED WITH THE INJUNCTION ON 9/21/2010.

3. PARAGRAPH 6 OF MESSAGE 0267307 CURRENTLY READS AS FOLLOWS:

COMMERCE'S APO DOCKET CENTER WAS SERVED WITH THE ABOVE REFERENCED INJUNCTION ON 09/21/2010. PURSUANT TO THE TERMS OF THE INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF 5 O'CLOCK PM ON THE FIFTH BUSINESS DAY AFTER WHICH COPIES OF THIS ORDER ARE PERSONALLY SERVED ON COMMERCE'S APO DOCKET CENTER.

4. INSTEAD, PARAGRAPH 6 OF MESSAGE NUMBER 0267307 SHOULD READ AS FOLLOWS:

COMMERCE'S APO DOCKET CENTER WAS SERVED WITH THE ABOVE REFERENCED INJUNCTION ON 09/24/2010.
