1. ON 08/20/2010 INSTRUCTIONS WERE ISSUED CONCERNING THE ANTIDUMPING DUTY ORDER ON POLYETHYLENE RETAIL CARRIER BAGS FROM THAILAND. THIS IS A CORRECTION OF PARAGRAPH 2 IN MESSAGE 0232305 DATED 08/20/2010.

2. MESSAGE 0232305 DATED 08/20/2010 DID NOT INDICATE THE CORRECT PRODUCT IN PARAGRAPH 2.

3. PARAGRAPH 2 OF MESSAGE 0232305 READS AS FOLLOWS:

THEREFORE, CBP IS DIRECTED TO TERMINATE THE SUSPENSION OF LIQUIDATION FOR ALL SHIPMENTS OF CERTAIN FROZEN WARMWATER SHRIMP PRODUCED AND EXPORTED BY THAI PLASTIC BAGS INDUSTRIES CO., LTD., WINNER'S PACK CO., LTD., AND/OR APEC FILM LTD. AND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 07/28/2010. ALL ENTRIES OF THE SUBJECT MERCHANDISE THAT WERE SUSPENDED ON OR AFTER 07/28/2010 SHOULD BE LIQUIDATED WITHOUT REGARD TO ANTIDUMPING DUTIES (I.E., RELEASE ALL BONDS AND REFUND ALL CASH DEPOSITS).

4. INSTEAD, PARAGRAPH 2 OF MESSAGE 0232305 SHOULD READ AS FOLLOWS:

THEREFORE, CBP IS DIRECTED TO TERMINATE THE SUSPENSION OF LIQUIDATION FOR ALL SHIPMENTS OF POLYETHYLENE RETAIL CARRIER BAGS FROM THAILAND PRODUCED AND EXPORTED BY THAI PLASTIC BAGS INDUSTRIES CO., LTD., WINNER'S PACK CO., LTD., AND/OR APEC FILM LTD. AND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 07/28/2010. ALL ENTRIES OF THE SUBJECT MERCHANDISE THAT WERE SUSPENDED ON OR AFTER 07/28/2010 SHOULD BE LIQUIDATED WITHOUT REGARD TO ANTIDUMPING DUTIES (I.E., RELEASE ALL BONDS AND REFUND ALL CASH DEPOSITS).
