FEDERATION (A-462-101)

1. COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (75 FR 51440) ON 08/20/2010 THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF A CERTAIN MANUFACTURER/EXPORTER SUBJECT TO THE ANTIDUMPING ORDER ON SOLID UREA FROM THE RUSSIAN FEDERATION FOR THE PERIOD 07/01/2008 THROUGH 06/30/2009.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATE HAS BEEN REVISED FOR A CERTAIN MANUFACTURER/EXPORTER. THEREFORE, FOR SHIPMENTS OF SOLID UREA FROM THE RUSSIAN FEDERATION ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 08/20/2010, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE MANUFACTURE/EXPORTER LISTED IN THE COMPANY-DETAIL TABLE APPENDED TO THIS MESSAGE.

3. IF ANY ENTRIES OF MERCHANDISE ARE EXPORTED BY A FIRM OTHER THAN THE MANUFACTURER, THEN THE FOLLOWING INSTRUCTIONS APPLY:

A. IF THE EXPORTER OF THE SUBJECT MERCHANDISE HAS ITS OWN RATE, USE THE EXPORTER'S RATE TO DETERMINE THE CASH DEPOSIT RATE.

B. IF THE EXPORTER OF THE SUBJECT MERCHANDISE DOES NOT HAVE ITS OWN RATE BUT THE MANUFACTURER HAS ITS OWN RATE, THE CASH DEPOSIT RATE WILL BE THE MANUFACTURER'S RATE.

C. WHERE NEITHER THE EXPORTER NOR THE MANUFACTURER CURRENTLY HAS ITS OWN RATE OR THE MANUFACTURER IS UNKNOWN, USE THE ALL-OTHERS RATE FOR ESTABLISHING THE CASH DEPOSIT RATE.

4. FOR ALL MANUFACTURERS/EXPORTERS OF SOLID UREA FROM THE RUSSIAN FEDERATION WITHOUT THEIR OWN RATE, THE CASH DEPOSIT RATE IS 64.93 PERCENT.

5. THESE CASH DEPOSIT REQUIREMENTS SHALL REMAIN IN EFFECT UNTIL FURTHER NOTICE. DO NOT LIQUIDATE ANY ENTRIES OF MERCHANDISE INCLUDED IN THIS ADMINISTRATIVE REVIEW UNTIL ASSESSMENT INSTRUCTIONS ARE RECEIVED.
