RE: CASH DEPOSIT INSTRUCTIONS FOR POLYETHYLENE RETAIL CARRIER BAGS FROM THAILAND PURSUANT TO FINAL RESULTS IN SECTION 129 DETERMINATION (A-549-821-000)

1. COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (75 FR 48940) ON 08/12/2010 THE IMPLEMENTATION OF ITS SECTION 129 DETERMINATION ON POLYETHYLENE RETAIL CARRIER BAGS FROM THAILAND.

2. AS A RESULT OF COMMERCE'S DETERMINATION, THE CASH DEPOSIT RATE HAS BEEN REVISED FOR MANUFACTURERS/EXPORTERS WITHOUT THEIR OWN RATE ('ALL OTHERS'). THEREFORE, FOR SHIPMENTS OF POLYETHYLENE RETAIL CARRIER BAGS FROM THAILAND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 07/28/2010, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE MANUFACTURER/EXPORTER LISTED IN THE COMPANY-DETAIL TABLE APPENDED TO THIS MESSAGE.

3. IF ANY ENTRIES OF MERCHANDISE ARE EXPORTED BY A FIRM OTHER THAN THE MANUFACTURER, THEN THE FOLLOWING INSTRUCTIONS APPLY:

A. IF THE EXPORTER OF THE SUBJECT MERCHANDISE HAS ITS OWN RATE, USE THE EXPORTER'S RATE TO DETERMINE THE CASH DEPOSIT RATE;

B. IF THE EXPORTER OF THE SUBJECT MERCHANDISE DOES NOT HAVE ITS OWN RATE BUT THE MANUFACTURER HAS ITS OWN RATE, THE CASH DEPOSIT RATE WILL BE THE MANUFACTURER'S RATE;

C. WHERE NEITHER THE EXPORTER NOR THE MANUFACTURER CURRENTLY HAS ITS OWN RATE OR THE MANUFACTURER IS UNKNOWN, USE THE 'ALL OTHERS' RATE FOR ESTABLISHING THE CASH DEPOSIT RATE.

4. FOR ALL MANUFACTURERS/EXPORTERS OF POLYETHYLENE RETAIL CARRIER BAGS FROM THAILAND WITHOUT THEIR OWN RATE, THE CASH DEPOSIT RATE IS 4.69

PERCENT.

5. THESE CASH DEPOSIT REQUIREMENTS SHALL REMAIN IN EFFECT UNTIL FURTHER NOTICE. DO NOT LIQUIDATE ANY ENTRIES OF MERCHANDISE SUBJECT TO THIS SECTION 129 DETERMINATION UNTIL YOU RECEIVE SPECIFIC INSTRUCTIONS.
