RE: RE: INJUNCTION ON CERTAIN NEW PNEUMATIC OFF-THE-ROAD TIRES FOR TIANJIN UNITED TIRE & RUBBER INTERNATIONAL CO., LTD. FROM THE PRC FOR THE PERIOD ON OR AFTER 12/17/2007 (C-570-913), COURT NO. 08-00285

1. ON 08/13/2010, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED AN INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE COUNTERVAILING DUTY ORDER ON CERTAIN NEW PNEUMATIC OFF-THE-ROAD TIRES FROM THE PEOPLE'S REPUBLIC OF CHINA C-570-913, FOR THE PERIOD ON OR AFTER 12/17/2007.

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 08-00285 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED IN PARAGRAPH #3 BELOW.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE EXPORTED BY TIANJIN UNITED TIRE & RUBBER INTERNATIONAL CO., LTD. (TUTRIC) AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION BEGINNING 12/17/2007. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

4. THIS INJUNCTION APPLIES TO THE LIQUIDATION INSTRUCTIONS COVERED BY MESSAGE NUMBERS 0144302 (DATE 05/24/2010), 9320012 (DATE 11/16/2009), AND 0022303 (DATE 01/22/2010).

5. EFFECTIVE IMMEDIATELY, CBP IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY ENTRIES SUBJECT TO THE ABOVE.

6. COMMERCE'S APO DOCKET CENTER RECEIVED THE ABOVE REFERENCED INJUNCTION ON 08/13/2010. PURSUANT TO THE TERMS OF THE INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF 08/13/2010.
