RE: ANTIDUMPING SCOPE RULING ON FOLDING METAL TABLES AND CHAIRS FROM THE PEOPLE'S REPUBLIC OF CHINA

1. COMMERCE RECEIVED A SCOPE RULING REQUEST FROM ACADEMY SPORTS AND OUTDOORS ("ACADEMY"). COMMERCE ISSUED A FINAL SCOPE RULING ON 07/27/2010, THAT THE THREE PIECE BISTRO SET, CONSISTING OF TWO CHAIRS AND ONE TABLE, PRODUCED BY JURONG SHENGYE METAL PIPES CO. LTD. ("JURONG SHENGYE"), WITH MODEL NUMBER SLMP0002, AND IMPORTED BY ACADEMY IS NOT WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING FOLDING METAL TABLES AND CHAIRS FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-868).

2. COMMERCE DETERMINED THAT THE THREE PIECE BISTRO SET PRODUCED BY JURONG SHENGYE WITH MODEL NUMBER SLMP0002 AND IMPORTED BY ACADEMY, CONSTITUTES LAWN FURNITURE, WHICH IS EXPRESSLY EXCLUDED FROM THE SCOPE OF THE ORDER. THEREFORE, THE THREE PIECE BISTRO SET PRODUCED BY JURONG SHENGYE WITH MODEL NUMBER SLMP0002 AND IMPORTED BY ACADEMY IS NOT WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING FOLDING METAL TABLES AND CHAIRS FROM THE PEOPLE'S REPUBLIC OF CHINA.

3. EFFECTIVE 07/27/2010, TERMINATE SUSPENSION AND LIQUIDATE ALL UNLIQUIDATED ENTRIES ENTERED, OR WITHDRAWN FROM WAREHOUSE OF THE THREE PIECE BISTRO SET LISTED ABOVE.

4. REFUND ANY CASH DEPOSITS WITH INTEREST AND RELEASE ANY BONDS RELATING TO THE THREE PIECE BISTRO SET LISTED ABOVE.

5. THESE INSTRUCTIONS CONSTITUTE NOTICE OF THE LIFTING OF SUSPENSION OF LIQUIDATION OF ENTRIES OF THE THREE PIECE BISTRO LISTED ABOVE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 07/27/2010.

6. THE ASSESSMENT OF ANTIDUMPING DUTIES BY CBP ON SHIPMENTS OR ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930. SECTION 778 REQUIRES THAT CBP PAY INTEREST ON OVERPAYMENTS,

OR ASSESS INTEREST ON UNDERPAYMENTS, OF THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED ANTIDUMPING DUTIES. THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED ANTIDUMPING DUTIES BEFORE THE DATE OF PUBLICATION OF THE ANTIDUMPING DUTY ORDER. INTEREST SHALL BE CALCULATED FROM THE DATE PAYMENT OF ESTIMATED ANTIDUMPING DUTIES IS REQUIRED THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.

7. FOR ALL OTHER SHIPMENTS OF FOLDING METAL TABLES AND CHAIRS FROM THE PEOPLE'S REPUBLIC OF CHINA NOT COVERED BY PARAGRAPH #2 ABOVE, YOU SHALL, UNLESS OTHERWISE INSTRUCTED, CONTINUE TO COLLECT CASH DEPOSITS OF ESTIMATED ANTIDUMPING DUTIES FOR THE MERCHANDISE AT THE CURRENT RATES.

8.
