1. COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (75 FR 38076) ON 07/01/2010 THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF A CERTAIN MANUFACTURER/EXPORTER SUBJECT TO THE ANTIDUMPING ORDER ON CARBAZOLE VIOLET PIGMENT 23 FROM INDIA FOR THE PERIOD 12/01/2007 THROUGH 11/30/2008.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATE HAS BEEN REVISED FOR ONE COMPANY.
