1. ON 06/18/2010, COMMERCE PUBLISHED IN THE FEDERAL REGISTER (75 FR 34688, 06/18/2010) ITS FINAL RESULTS IN THE CHANGED-CIRCUMSTANCES REVIEW OF THE ANTIDUMPING DUTY ORDER ON BALL BEARINGS AND PARTS THEREOF FROM FRANCE.

2. NTN CORPORATION ACQUIRED A MAJORITY OWNERSHIP OF SOCIETE NOUVELLE DE ROULEMENTS (SNR). SNR, WHICH HAD PREVIOUSLY HAD ITS OWN CASH-DEPOSIT RATE, REQUESTED THAT COMMERCE CONDUCT A CHANGED-CIRCUMSTANCES REVIEW TO ASCERTAIN WHETHER POST-ACQUISITION SNR IS THE SUCCESSOR-IN-INTEREST TO PRE-ACQUISITION SNR. COMMERCE COMPLETED THE REVIEW AND FOUND THAT POST-ACQUISITION SNR IS THE SUCCESSOR-IN-INTEREST TO PRE-ACQUISITION SNR AND, THEREFORE, SHOULD HAVE THE SAME CASH-DEPOSIT RATE AS PRE-ACQUISITION SNR.

3. ACCORDINGLY, FOR SHIPMENTS OF BALL BEARINGS AND PARTS THEREOF FROM FRANCE WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 06/18/2010, CBP SHALL REQUIRE THE FOLLOWING CASH-DEPOSIT RATE:
