RE: Notice of preliminary determination in the countervailing duty investigation of steel threaded rod from India (C-533-856)

1. On 12/19/2013, Commerce published in the Federal Register its preliminary affirmative determination and alignment of its final determination in the countervailing duty investigation of steel threaded rod from India from 02/24/2014 until no later than 04/28/2014, thereby aligning it with the due date for the final determination in the antidumping duty investigation of steel threaded rod from India (78 FR 76815).
2. The products covered by this investigation are described in message 3226307, dated 08/14/2013.
3. This investigation has been assigned investigation number C-533-856.
4. For imports of steel threaded rod from India, CBP shall suspend liquidation of such shipments entered, or withdrawn from warehouse, for consumption on or after 12/19/2013. Effective 12/19/2013, CBP shall require, for such entries, a cash deposit or the posting of a bond equal to the subsidy rates for the companies listed below:

Producer and/or Exporter: Babu Exports
