THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (75 FR 29720) ON 05/27/2010 THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF A CERTAIN EXPORTER SUBJECT TO THE ANTIDUMPING ORDER ON CERTAIN HELICAL SPRING LOCK WASHERS FROM THE PEOPLE'S REPUBLIC OF CHINA ("PRC") FOR THE PERIOD 10/01/2007 THROUGH 09/30/2008.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATE HAS BEEN REVISED FOR A CERTAIN EXPORTER.
