RE: PRELIMINARY INJUNCTION ON CERTAIN FROZEN FISH FILLETS FROM VIETNAM PRODUCED AND/OR EXPORTED BY QVD FOOD CO., QVD DONG, THUAN HUNG, EAST SEA SEAFOODS (2), GIANG FISHERIES, VINH HOAN (2) (A-552-801)

1. ON 04/22/2010, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON CERTAIN FROZEN FISH FILLETS FROM SOCIALIST REPUBLIC OF VIETNAM A-552-801, FOR THE PERIOD 08/01/2007 THROUGH 07/31/2008.

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 10-00131 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED IN PARAGRAPH #3 BELOW.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE PRODUCED AND/OR EXPORTED BY QVD FOOD COMPANY LTD., QVD DONG THAP FOOD CO., LTD., THUAN HUNG CO., LTD., EAST SEA SEAFOODS JOINT VENTURE CO. LTD., EAST SEA SEAFOODS LLC, AN GIANG FISHERIES IMPORT AND EXPORT JOINT STOCK COMPANY (AKA AGIFISH), VINH HOAN CO., LTD, OR VINH HOAN CORPORATION, AND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 08/01/2007 THROUGH 07/31/2008. ANY ENTRIES THAT ARE SET FOR LIQUIDATION MUST BE UNSET IMMEDIATELY. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

4. THIS INJUNCTION APPLIES TO THE LIQUIDATION INSTRUCTIONS COVERED BY MESSAGE NUMBERS 0098304, 0099308, AND 0109303, DATED 04/08/2010, 04/09/2010, 04/19/2010, RESPECTIVELY. ANY ENTRIES THAT ARE SET FOR LIQUIDATION MUST BE UNSET IMMEDIATELY.

5. EFFECTIVE IMMEDIATELY, CBP IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY ENTRIES SUBJECT TO THE ABOVE.

6. COMMERCE'S APO DOCKET CENTER WAS SERVED WITH THE ABOVE REFERENCED INJUNCTION ON 04/22/2010. PURSUANT TO THE TERMS OF THE INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF THE FIFTH BUSINESS DAY AFTER WHICH COPIES OF THIS ORDER ARE PERSONALLY SERVED ON COMMERCE'S APO DOCKET CENTER.
