THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (75 FR 12726) ON 03/17/2010 THE FINAL RESULTS OF ADMINISTRATIVE REVIEW OF CERTAIN EXPORTERS SUBJECT TO THE ANTIDUMPING ORDER ON CERTAIN FROZEN FISH FILLETS FROM THE SOCIALIST REPUBLIC OF VIETNAM FOR THE PERIOD 08/01/2007 THROUGH 07/31/2008.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES HAVE BEEN REVISED FOR CERTAIN EXPORTERS.
