THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (75 FR 8301) ON 02/24/2010 THE FINAL RESULTS OF ADMINISTRATIVE REVIEW OF CERTAIN EXPORTERS SUBJECT TO THE ANTIDUMPING ORDER ON CERTAIN CUT-TO-LENGTH CARBON STEEL PLATE FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-849) FOR THE PERIOD 11/01/2007 THROUGH 10/31/2008.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES HAVE BEEN REVISED FOR CERTAIN EXPORTERS. THEREFORE, FOR SHIPMENTS OF CERTAIN CUT-TO-LENGTH CARBON STEEL PLATE FROM THE PEOPLE'S REPUBLIC OF CHINA ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 02/24/2010, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE EXPORTERS LISTED IN THE COMPANY DETAILS SECTION BELOW.

3. IF ANY ENTRIES OF THIS MERCHANDISE ARE EXPORTED BY A FIRM OTHER THAN THE EXPORTERS LISTED ABOVE, THEN THE FOLLOWING INSTRUCTIONS APPLY:
