RE: PRELIMINARY INJUNCTION ON CERTAIN STEEL NAILS FOR NATIONAL NAIL CORP. FROM THE PEOPLE'S REPUBLIC OF CHINA ON OR AFTER 01/23/2008, (A-570-909), COURT NUMBER 10-00043

1. ON 03/23/2010, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES OF PLASTIC CAP STEEL NAILS WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON CERTAIN STEEL NAILS FROM THE PEOPLE'S REPUBLIC OF CHINA A-570-909, ON OR AFTER 01/23/2008.

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER COURT NUMBER 10-00043 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED IN PARAGRAPH #3 BELOW.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF PLASTIC CAP STEEL NAILS WHICH WERE IMPORTED BY, OR ON BEHALF OF, NATIONAL NAIL CORPORATION, AND WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 01/23/2008. ANY ENTRIES THAT ARE SET FOR LIQUIDATION MUST BE UNSET IMMEDIATELY. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

4. LIQUIDATION INSTRUCTIONS FOR ENTRIES AFFECTED BY THIS INJUNCTION HAVE NOT YET BEEN ISSUED.

5. EFFECTIVE IMMEDIATELY, CBP IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY ENTRIES SUBJECT TO THE ABOVE.

6. COMMERCE'S APO DOCKET CENTER WAS SERVED WITH THE ABOVE REFERENCED INJUNCTION ON 03/24/2010.
