RE: PRELIMINARY INJUNCTION ON FRESH GARLIC EXPORTED FROM CHINA BY JINAN YIPIN, LINSHU DADING OR SUNNY IMP/EXP (A-570-831-003/015/029)

1. ON 03/04/2010, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON FRESH GARLIC FROM THE PEOPLE'S REPUBLIC OF CHINA A-570-831, FOR THE PERIOD 11/01/2003 THROUGH 10/31/2004.

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT NO. 06-00189 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED IN PARAGRAPH #3 BELOW.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF CERTAIN FRESH GARLIC FROM THE PEOPLE'S REPUBLIC OF CHINA THAT WERE EXPORTED TO THE UNITED STATES BY JINAN YIPIN CORPORATION, LTD. (A-570-831-003), LINSHU DADING PRIVATE AGRICULTURAL PRODUCTS CO., LTD. (A-570-831-029) OR SUNNY IMPORT AND EXPORT CO., LTD. (A-570-831-015); AND ARE CLASSIFIABLE UNDER HARMONIZED TARIFF SCHEDULE (HTS) SUBHEADINGS 0703.20.0010, 0703.20.0020, 0703.20.0090, 0710.80.7060, 0710.80.9750, 0711.90.6000 OR 2005.90.9700; AND WERE ENTERED OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD OF NOVEMBER 1, 2003, THROUGH OCTOBER 31, 2004. ANY ENTRIES THAT ARE SET FOR LIQUIDATION MUST BE UNSET IMMEDIATELY. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

4. LIQUIDATION INSTRUCTIONS FOR ENTRIES AFFECTED BY THIS INJUNCTION HAVE NOT YET BEEN ISSUED.

5. EFFECTIVE IMMEDIATELY, CBP IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY ENTRIES SUBJECT TO THE ABOVE.

6. COMMERCE'S APO DOCKET CENTER WAS SERVED WITH THE ABOVE REFERENCED INJUNCTION ON 03/05/2010. PURSUANT TO THE TERMS OF THE INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR

ENTRIES WHICH REMAIN UNLIQUIDATED AS OF FIVE P.M. ON THE FIFTH BUSINESS DAY AFTER WHICH COPIES OF THIS ORDER ARE PERSONALLY SERVED ON COMMERCE'S APO DOCKET CENTER.
