THE DEPARTMENT OF COMMERCE HAS COMPLETED ITS ADMINISTRATIVE REVIEW OF THE COUNTERVAILING DUTY ORDER (C-507-601) ON CERTAIN IN-SHELL ROASTED PISTACHIOS FROM IRAN FOR THE PERIOD JANUARY 1, 2004, THROUGH DECEMBER 31, 2004 AND PUBLISHED THE FINAL RESULTS IN THE FEDERAL REGISTER ON NOVEMBER 13, 2006 (71 FR 66165).

2. IMPORTS COVERED BY THE REVIEW ARE ALL ROASTED IN-SHELL PISTACHIO NUTS, WHETHER ROASTED IN IRAN OR ELSEWHERE, FROM WHICH

THE HULL HAS BEEN REMOVED, LEAVING THE INNER HARD SHELLS AND THE EDIBLE MEAT, AS CURRENTLY CLASSIFIABLE IN THE HTSUS UNDER ITEM NUMBER 0802.50.20.00. ALTHOUGH THE HTSUS SUBHEADING IS PROVIDED FOR CONVENIENCE AND CUSTOMS PURPOSES, THE WRITTEN DESCRIPTION OF THE MERCHANDISE IS DISPOSITIVE.

3. ACCORDINGLY, FOR SHIPMENTS OF CERTAIN IN-SHELL ROASTED PISTACHIOS FROM IRAN, ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER NOVEMBER 13, 2006, YOU SHALL COLLECT A CASH DEPOSIT OF ESTIMATED COUNTERVAILING DUTIES AT THE FOLLOWING PERCENTAGES OF THE ENTERED VALUE PRICE:
