2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES

HAVE BEEN REVISED FOR CERTAIN MANUFACTURERS/EXPORTERS.

ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR
