1. ON 01/25/2007, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A
PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES
WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON STAINLESS
STEEL BUTT-WELD PIPE FITTINGS FROM TAIWAN (A-583-816-001),
MANUFACTURED AND/OR EXPORTED BY TA CHEN STAINLESS PIPE CO., LTD.
FOR THE PERIOD 06/01/2004 THROUGH 05/31/2005.

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE

NUMBER 06-00454 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED ABOVE.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE PRODUCED AND/OR EXPORTED BY TA

CHEN STAINLESS PIPE CO., LTD. AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 06/01/2004 THROUGH 05/31/2005. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

4. THIS INJUNCTION APPLIES TO THE LIQUIDATION INSTRUCTIONS COVERED BY MESSAGE NUMBER 7016203, DATED 01/16/2007.

5. EFFECTIVE IMMEDIATELY, U.S. CUSTOMS AND BORDER PROTECTION (CBP) IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY ENTRIES SUBJECT TO THE ABOVE.

6. THE DEPARTMENT OF COMMERCE WAS SERVED WITH THE ABOVE REFERENCED INJUNCTION ON 01/30/2007. PURSUANT TO THE TERMS OF THE INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF 5:00 P.M. ON THE FIFTH BUSINESS DAY AFTER THE DATE ON WHICH THIS ORDER IS PERSONALLY SERVED BY PLAINTIFFS TO THE ADMINISTRATIVE PROTECTIVE ORDER DOCKET CENTER OF THE U.S. DEPARTMENT OF COMMERCE.
