THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (71 FR 75710) ON 12/18/2006 THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF CHINA METALLURGICAL IMPORT & EXPORT LIAONING COMPANY SUBJECT TO THE ANTIDUMPING ORDER ON CUT-TO-LENGTH CARBON STEEL PLATE FROM THE PEOPLE'S REPUBLIC OF CHINA FOR THE PERIOD 11/01/2004 THROUGH 10/31/2005.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES HAVE

BEEN REVISED FOR CHINA METALLURGICAL IMPORT & EXPORT LIAONING COMPANY. THEREFORE, FOR SHIPMENTS OF CUT-TO-LENGTH CARBON STEEL PLATE FROM THE PEOPLE'S REPUBLIC OF CHINA ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 12/08/2006, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING EXPORTER:
