1. THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (71 FR 54266) ON 09/14/ 2006 THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF CERTAIN MANUFACTURERS/EXPORTERS SUBJECT

TO THE ANTIDUMPING ORDER ON CIRCULAR WELDED CARBON STEEL PIPES AND TUBES FROM THAILAND FOR THE PERIOD 03/01/2004 THROUGH 02/28/2005.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES

HAVE BEEN REVISED FOR CERTAIN MANUFACTURERS/EXPORTERS.
THEREFORE, FOR SHIPMENTS OF CIRCULAR WELDED CARBON STEEL PIPES
AND TUBES FROM THAILAND ENTERED, OR WITHDRAWN FROM WAREHOUSE,
FOR CONSUMPTION ON OR AFTER 09/14/2006, THE REQUIRED CASH
DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING
MANUFACTURER/EXPORTER:

SAHA THAI STEEL PIPE CO.,LTD. A-549-502-001 2.26 PERCENT.

3. IF ANY ENTRIES OF THIS MERCHANDISE ARE EXPORTED BY A FIRM

CASH DEPOSIT RATE IS 15.67 PERCENT.

5. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL
PUBLICATION OF THE FINAL RESULTS OF FOR THE NEXT ADMINISTRATIVE
REVIEW. DO NOT LIQUIDATE ANY ENTRIES COVERED BY THIS REVIEW
UNTIL YOU HAVE RECEIVED LIQUIDATION INSTRUCTIONS.
