RE: ANTIDUMPING SCOPE RULING ON WOODEN BEDROOM FURNITURE  
FROM CHINA A-570-890 SPECIFIED STORAGE TOWERS,  
TV STANDS, COFFEE TABLES & WOOD PANELS NOT W/IN SCOPE

1. ON NOVEMBER 27, 2006, IN RESPONSE TO A REQUEST BY TUOHY  
FURNITURE CORPORATION, THE DEPARTMENT OF COMMERCE ISSUED A FINAL  
SCOPE RULING THAT STORAGE TOWERS (ITEMS AE 001 A/B, AE 001C, AE  
011, AE 020, AND AE 022), TV STANDS (ITEM AE 023A/B), COFFEE  
TABLES (ITEMS F018 AND F019), AND WOOD PANELS (ITEMS AE 005, AE  
006, AND AE 007) ARE NOT WITHIN THE SCOPE OF THE ANTIDUMPING  
DUTY ORDER COVERING WOODEN BEDROOM FURNITURE FROM THE PRC  
(A-570-890).

2. THE COMMERCE DEPARTMENT DETERMINED THAT STORAGE TOWERS (ITEMS AE 001 A/B, AE 001C, AE 011, AE 020, AND AE 022), TV STANDS (ITEM AE 023A/B), COFFEE TABLES (ITEMS F018 AND F019), AND WOOD PANELS (ITEMS AE 005, AE 006, AND AE 007) IMPORTED BY TUOHY FURNITURE CORPORATION FIT THE DESCRIPTION OF ITEMS EXCLUDED FROM THE SCOPE OF THE ORDER ON WOODEN BEDROOM FURNITURE FROM THE PRC.

3. EFFECTIVE NOVEMBER 27, 2006, TERMINATE SUSPENSION AND LIQUIDATE ALL UNLIQUIDATED ENTRIES ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER JUNE 24, 2004 OF THE STORAGE TOWERS, TV STANDS, COFFEE TABLES, AND WOOD PANELS LISTED ABOVE.

4. REFUND ANY CASH DEPOSITS WITH INTEREST AND RELEASE ANY BONDS RELATING TO THE STORAGE TOWERS, TV STANDS, COFFEE TABLES, AND WOOD PANELS LISTED ABOVE.

5. THE ASSESSMENT OF ANTIDUMPING DUTIES BY CUSTOMS AND BORDER PROTECTION ON ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930. SECTION 778 REQUIRES THAT CBP PAY INTEREST ON OVERPAYMENTS, OR ASSESS INTEREST ON UNDER PAYMENTS, OF THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED ANTIDUMPING DUTIES. THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED ANTIDUMPING DUTIES BEFORE THE DATE OF PUBLICATION OF THE ANTIDUMPING DUTY ORDER. INTEREST SHALL BE CALCULATED FROM THE DATE PAYMENT OF ESTIMATED ANTIDUMPING DUTIES IS REQUIRED THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.

6. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF WOODEN BEDROOM FURNITURE SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING WOODEN

BEDROOM FURNITURE FROM THE PRC.
