TO THE ANTIDUMPING ORDER ON NON-MALLEABLE CAST IRON PIPE FITTINGS FROM THE PRC FOR THE PERIOD 04/01/2004 THROUGH 03/31/2005.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATE HAS
