1. ON FEBRUARY 26,2007, IN RESPONSE TO A REQUEST BY CONTESSA PREMIUM FOODS, THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT CONTESSA'S ENROBED SHRIMP(TM) IS WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING CERTAIN FROZEN WARMWATER SHRIMP FROM BRAZIL (A-351-838).

2. BECAUSE THE IMPORTED PRODUCT MEETS THE DEFINITION OF THE PRODUCTS INCLUDED IN THE SCOPE OF THE ORDER, THE COMMERCE DEPARTMENT FOUND THIS PRODUCT TO BE WITHIN THE SCOPE OF THE

ORDER.

3. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF CERTAIN FROZEN WARMWATER SHRIMP FROM BRAZIL, INCLUDING CONTESSA'S ENROBED SHRIMP(TM) LISTED ABOVE SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING CERTAIN FROZEN WARMWATER SHRIMP FROM BRAZIL.
