1. THE DEPARTMENT OF COMMERCE HAS COMPLETED ITS ADMINISTRATIVE REVIEW OF THE COUNTERVAILING DUTY ORDER (C-533-825) ON POLYETHYLENE TEREPHTHALATE FILM (PET FILM) FROM INDIA FOR THE 01/01/2004 THROUGH 12/31/2004 PERIOD AND PUBLISHED THE FINAL RESULTS IN THE FEDERAL REGISTER ON 02/12/2007.

2. IMPORTS COVERED BY THE REVIEW ARE SHIPMENTS OF ALL GAUGES OF RAW, PRETREATED, OR PRIMED POLYETHYLENE TEREPHTHALATE FILM, SHEET AND STRIP, WHETHER EXTRUDED OR COEXTRUDED. EXCLUDED ARE

METALLIZED FILMS AND OTHER FINISHED FILMS THAT HAVE HAD AT LEAST ONE OF THEIR SURFACES MODIFIED BY THE APPLICATION OF A PERFORMANCE-ENHANCING RESINOUS OR INORGANIC LAYER OF MORE THAN 0.00001 INCHES THICK. IMPORTS OF PET FILM ARE CLASSIFIABLE IN THE HARMONIZED TARIFF SCHEDULE OF THE UNITED STATES (HTSUS) UNDER ITEM NUMBER 3920.62.00. HTSUS SUBHEADINGS ARE PROVIDED FOR CONVENIENCE AND CUSTOMS PURPOSES. THE WRITTEN DESCRIPTION OF THE SCOPE OF THIS PROCEEDING IS DISPOSITIVE.

3. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES HAVE BEEN REVISED FOR CERTAIN MANUFACTURERS/EXPORTERS. THEREFORE, SHIPMENTS OF PET FILM FROM INDIA, ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 02/12/2007, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING MANUFACTURERS/EXPORTERS:
