1. NOTICE OF THE LIFTING OF SUSPENSION OF LIQUIDATION OF
ENTRIES OF SUBJECT MERCHANDISE OCCURRED WITH THE PUBLICATION OF
THE FINAL RESULTS OF ADMINISTRATIVE REVIEW OF THE COUNTERVAILING
DUTY ORDER (C-507-601) ON CERTAIN IN- SHELL ROASTED PISTACHIOS
FROM THE ISLAMIC REPUBLIC OF IRAN FOR THE PERIOD JANUARY 1,
2004, THROUGH DECEMBER 31, 2004 (71 FR 66165, NOVEMBER 13,
2006).

2. IMPORTS COVERED BY THE REVIEW ARE SHIPMENTS OF ROASTED IN-

SHELL PISTACHIO NUTS, WHETHER ROASTED IN IRAN OR ELSEWHERE, FROM WHICH THE HULL HAS BEEN REMOVED, LEAVING THE INNER HARD SHELLS AND THE EDIBLE MEAT, AS CURRENTLY CLASSIFIABLE IN THE HTSUS UNDER ITEM NUMBER 0802.50.20.00. ALTHOUGH THE HTSUS SUBHEADING IS PROVIDED FOR CONVENIENCE AND CUSTOMS PURPOSES, THE WRITTEN DESCRIPTION OF THE MERCHANDISE IS DISPOSITIVE.

3. ACCORDINGLY, YOU ARE NOW INSTRUCTED TO LIQUIDATE ALL SHIPMENTS OF CERTAIN IN-SHELL ROASTED PISTACHIOS FROM THE ISLAMIC REPUBLIC OF IRAN EXPORTED ON OR AFTER JANUARY 1, 2004, AND ON OR BEFORE DECEMBER 31, 2004, AT THE FOLLOWING PERCENT OF ENTERED VALUE:

INTEREST SHALL BE CALCULATED FROM THE DATE OF PAYMENT OF ESTIMATED COUNTERVAILING DUTIES

THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.

5. THE SUSPENSION OF LIQUIDATION ORDERED FOR THIS MERCHANDISE EXPORTED ON OR BEFORE DECEMBER 31, 2004 IS LIFTED. SUSPENSION OF LIQUIDATION FOR ALL ENTRIES OF THIS MERCHANDISE EXPORTED AFTER DECEMBER 31, 2004 WILL CONTINUE.
