1. THE DEPARTMENT OF COMMERCE ("COMMERCE") HAS PUBLISHED IN THE FEDERAL REGISTER (72 FR 6524) ON FEBRUARY 12, 2007 THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF CERTAIN MANUFACTURERS/EXPORTERS SUBJECT TO THE ANTIDUMPING ORDER ON IQF

RED RASPBERRIES FROM CHILE FOR THE PERIOD 07/01/2004 THROUGH 06/30/2005.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES

HAVE BEEN REVISED FOR CERTAIN MANUFACTURERS/EXPORTERS.
THEREFORE, FOR SHIPMENTS OF IQF RED RASPBERRIES FROM CHILE
ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR
AFTER 02/12/2007, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR
THE FOLLOWING MANUFACTURERS/EXPORTERS:

4. FOR ALL MANUFACTURERS/EXPORTERS OF IQF RED RASPBERRIES FROM

CHILE WITHOUT THEIR OWN RATE, THE CASH DEPOSIT RATE IS 6.33 PERCENT.

5. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS FOR THE NEXT ADMINISTRATIVE REVIEW. DO NOT LIQUIDATE ANY ENTRIES COVERED BY THIS REVIEW UNTIL YOU HAVE RECEIVED LIQUIDATION INSTRUCTIONS.
