RE: SUNSET REVOCATION OF COUNTERVAILING DUTY ORDER ON CUT- TO-LENGTH CARBON STEEL PLATE FROM SPAIN, (COMMERCE CASE C-469-804) (CBP CASE C-470-209)

1. AS A RESULT OF A FIVE-YEAR ("SUNSET") REVIEW, THE U.S. DEPARTMENT OF COMMERCE (COMMERCE) HAS REVOKED THE COUNTERVAILING

DUTY ORDER ON CUT-TO-LENGTH CARBON STEEL PLATE FROM SPAIN (COMMERCE CASE NUMBER: C-469-804, CBP CASE NUMBER: C-470-209). THIS REVOCATION WAS PUBLISHED IN THE FEDERAL REGISTER ON 02/12/2007(72 FR 6519). THE EFFECTIVE DATE OF THE REVOCATION IS 12/15/2005.

2. U.S. CUSTOMS AND BORDER PROTECTION (CBP) IS DIRECTED TO TERMINATE THE SUSPENSION OF LIQUIDATION FOR ALL SHIPMENTS OF CUT-TO-LENGTH CARBON STEEL PLATE FROM SPAIN, ENTERED OR WITHDRAWN

FROM WAREHOUSE FOR CONSUMPTION, ON OR AFTER 12/15/2005. ALL ENTRIES OF THE SUBJECT MERCHANDISE THAT WERE SUSPENDED ON OR AFTER 12/15/2005 SHOULD BE LIQUIDATED WITHOUT REGARD TO COUNTERVAILING DUTIES (I.E., RELEASE ALL BONDS AND REFUND ALL CASH DEPOSITS, WITH INTEREST).

3. LIQUIDATION INSTRUCTIONS COVERING ENTRIES OF CUT-TO-LENGTH CARBON STEEL PLATE FROM SPAIN DURING THE PERIOD 01/01/2005 THROUGH 12/31/2005 WERE PREVIOUSLY ISSUED UNDER MESSAGE NUMBER 6290203 (DATED 10/17/2006). MESSAGE 6290203 IS STILL IN EFFECT FOR ENTRIES DURING THE PERIOD 01/01/2005 THROUGH 12/14/2005, BUT IS SUPERCEDED BY PARAGRAPH 2 ABOVE WITH RESPECT TO ENTRIES ON OR AFTER 12/15/2005.

4. THE ASSESSMENT OF COUNTERVAILING DUTIES BY CBP ON ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930. SECTION 778 REQUIRES THAT CBP PAY INTEREST ON OVERPAYMENTS, OR ASSESS INTEREST ON UNDERPAYMENTS, OF THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED COUNTERVAILING DUTIES. THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED COUNTERVAILING DUTIES BEFORE THE DATE OF PUBLICATION OF THE COUNTERVAILING DUTY ORDER. INTEREST SHALL BE CALCULATED FROM THE DATE OF PAYMENT OF ESTIMATED COUNTERVAILING DUTIES THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.
