1. THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (71 FR 24643) ON 04/26/2006 THE FINAL RESULTS OF ITS CHANGED CIRCUMSTANCES REVIEW OF THE ANTIDUMPING ORDER ON STAINLESS STEEL WIRE ROD FROM ITALY (A-475-820).

2. AS A RESULT OF THE CHANGED CIRCUMSTANCES REVIEW, THE DEPARTMENT HAS DETERMINED THAT VALBRUNA S.P.A. IS THE SUCCESSOR-IN-INTEREST TO VALBRUNA S.R.L./BOLZANO S.P.A. BECAUSE VALBRUNA S.R.L./BOLZANO S.P.A. IS EXCLUDED FROM THE ANTIDUMPING DUTY

ORDER (SEE MESSAGE #8272114 DATED 9/29/1998), CUSTOMS IS DIRECTED TO TERMINATE THE SUSPENSION OF LIQUIDATION EFFECTIVE 12/16/1998, AND LIQUIDATE ENTRIES PRODUCED AND EXPORTED BY VALBRUNA S.P.A WITHOUT REGARD TO ANTIDUMPING DUTIES (I.E., RELEASE ALL BONDS AND REFUND ALL CASH DEPOSITS).

3. NOTICE OF THE LIFTING OF SUSPENSION OF LIQUIDATION OF ENTRIES OF SUBJECT MERCHANDISE PRODUCED OR EXPORTED BY VALBRUNA

S.P.A ON OR AFTER 12/16/1998 OCCURRED WITH THE PUBLICATION OF THE FINAL RESULTS OF THE CHANGED CIRCUMSTANCES REVIEW (71 FR 24643 ON 04/26/2006). FOR ALL OTHER SHIPMENTS OF STAINLESS STEEL WIRE ROD FROM ITALY YOU SHALL, UNLESS OTHERWISE INSTRUCTED, CONTINUE TO COLLECT CASH DEPOSITS OF ESTIMATED ANTIDUMPING DUTIES FOR THE MERCHANDISE AT THE CURRENT RATES.

4. THE ASSESSMENT OF ANTIDUMPING DUTIES BY CUSTOMS AND BORDER PROTECTION ON ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930. SECTION 778 REQUIRES THAT CBP PAYS INTEREST ON OVERPAYMENTS AND ASSESS

INTEREST ON UNDERPAYMENTS OF THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED ANTIDUMPING DUTIES. THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED ANTIDUMPING DUTIES BEFORE THE DATE OF PUBLICATION OF THE ANTIDUMPING DUTY ORDER. INTEREST SHALL BE CALCULATED FROM THE DATE OF PAYMENT OF ESTIMATED ANTIDUMPING DUTIES THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.
