THE DEPARTMENT OF COMMERCE ("DEPARTMENT") HAS PUBLISHED IN THE FEDERAL REGISTER (72 FR 23800) ON 5/1/2007, THE AMENDED FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF CERTAIN MANUFACTURERS/EXPORTERS SUBJECT TO THE ANTIDUMPING DUTY ORDER ON CERTAIN FROZEN FISH FILLETS FROM VIETNAM FOR THE PERIOD 08/01/2004 THROUGH 07/31/2005.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT

RATES HAVE BEEN REVISED FOR CERTAIN MANUFACTURERS/EXPORTERS. THEREFORE, FOR SHIPMENTS OF CERTAIN FROZEN FISH FILLETS FROM VIETNAM ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 05/1/2007, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING MANUFACTURERS/EXPORTERS:

PLEASE NOTE THAT THE SIX COMPANIES LISTED ABOVE IN THESE INSTRUCTIONS, NAM VIET COMPANY LIMITED, VINH LONG IMPORT-EXPORT COMPANY, AN GIANG AGRICULTURE AND FOOD IMPORT EXPORT COMPANY, CAN THO AGRICULTURAL AND ANIMAL PRODUCTS IMPORT EXPORT COMPANY, MEKONG FISHERIES JOINT STOCK COMPANY, AND PHAN QUAN COMPANY, LTD., WERE NOT LISTED SEPARATELY IN THE DEPARTMENT'S AMENDED FINAL RESULTS (72 FR 23800, MAY 1, 2007), BECAUSE THEY WERE ASSIGNED THE VIETNAM-WIDE ENTITY RATE AT THE DEPARTMENT'S PRELIMINARY RESULTS (71 FR 53387, SEPTEMBER 11, 2006).

3. IF ANY ENTRIES OF THIS MERCHANDISE ARE EXPORTED BY A FIRM OTHER THAN THE MANUFACTURER LISTED ABOVE, THEN THE FOLLOWING INSTRUCTIONS APPLY:

A. IF THE VIETNAM OR NON-VIETNAM EXPORTER OF THE SUBJECT MERCHANDISE HAS ITS OWN RATE, USE THE APPLICABLE EXPORTER'S RATE FOR DETERMINING THE CASH DEPOSIT RATE.

B. FOR ALL VIETNAM EXPORTERS OF SUBJECT MERCHANDISE, WHICH HAVE NOT BEEN ASSIGNED TO A SEPARATE RATE, THE CASH-DEPOSIT RATE WILL BE THE VIETNAM-WIDE RATE OF 63.88 PERCENT.

C. FOR ALL NON-VIETNAM EXPORTERS OF SUBJECT MERCHANDISE WHICH HAVE NOT RECEIVED THEIR OWN RATE, THE CASH-DEPOSIT RATE WILL BE THE RATE APPLICABLE TO THE VIETNAM EXPORTER THAT SUPPLIED THAT NON-VIETNAM EXPORTER.

4. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL FURTHER NOTICE. DO NOT LIQUIDATE ANY ENTRIES OF MERCHANDISE INCLUDED IN THIS ADMINISTRATIVE REVIEW UNTIL ASSESSMENT INSTRUCTIONS ARE RECEIVED.
