1. ON 4/26/2007, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A
PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES
WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON CERTAIN
CORROSION-RESISTANT CARBON STEEL FLAT PRODUCTS FROM CANADA
(A-122-822) PRODUCED BY DOFASCO INC., SOREVCO INC., OR DO SOL
GALVA LTD. (AKA DOSOL GALVA, LTD.), AND IMPORTED BY OR SOLD TO
DOFASCO INC.; OR PRODUCED BY DOFASCO INC., SOREVCO INC., OR DO
SOL GALVA, LTD. (AKA DOSOL GALVA, LTD.), AND PROCESSED BY DJ

GALVANIZING LTD. PARTNERSHIP (DJG) (FORMERLY DNN GALVANIZING LTD. PARTNERSHIP) AND IMPORTED BY OR SOLD TO DOFASCO INC. FOR THE PERIOD 08/01/2004 THROUGH 07/31/2005.

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 07-00135 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED ABOVE.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE PRODUCED BY DOFASCO INC., SOREVCO INC., OR DO SOL GALVA LTD. (AKA DOSOL GALVA, LTD.), AND IMPORTED BY OR SOLD TO DOFASCO INC.; OR PRODUCED BY DOFASCO INC., SOREVCO INC., OR DO SOL GALVA, LTD. (AKA DOSOL GALVA, LTD.), AND PROCESSED BY DJ GALVANIZING LTD. PARTNERSHIP (DJG) (FORMERLY DNN GALVANIZING LTD. PARTNERSHIP) AND IMPORTED BY OR SOLD TO DOFASCO INC. AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION, BETWEEN AUGUST 1, 2004 AND JULY 31, 2005, INCLUSIVE.

4. LIQUIDATION INSTRUCTIONS FOR ENTRIES AFFECTED BY THIS INJUNCTION HAVE NOT YET BEEN ISSUED.

5. EFFECTIVE IMMEDIATELY, CBP IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY ENTRIES SUBJECT TO THE ABOVE.

6. THE DEPARTMENT OF COMMERCE WAS SERVED WITH THE ABOVE REFERENCED INJUNCTION ON 4/27/2007. PURSUANT TO THE TERMS OF THE INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF 5 O'CLOCK P.M. ON THE FIFTH BUSINESS DAY AFTER 4/27/2007.
