1. ON 05/17/2007, THE COURT OF INTERNATIONAL TRADE ISSUED A TEMPORARY RESTRAINING ORDER RESTRAINING, FOR 10 DAYS FROM DATE OF SERVICE, LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON CERTAIN CORROSION-RESISTANT CARBON

STEEL FLAT PRODUCTS FROM CANADA (A-122-822) IMPORTED BY PARKDALE INTERNATIONAL LTD. ON OR AFTER 9/26/2000.

THIS TEMPORARY RESTRAINING ORDER ONLY COVERS CERTAIN CORROSION-RESISTANT CARBON STEEL FLAT PRODUCTS FROM CANADA IMPORTED BY PARKDALE INTERNATIONAL LTD., WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER SEPTEMBER 26, 2000, AND REMAIN UNLIQUIDATED AS OF 5:00 P.M., MAY 17, 2007.
