ON 04/17/2007, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF FLOOR-STANDING METAL-TOP IRONING TABLES, ASSEMBLED OR UNASSEMBLED, COMPLETE OR INCOMPLETE AND CERTAIN PARTS THEREOF FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-888), MANUFACTURED OR EXPORTED BY SINCE HARDWARE (GUANGZHOU) CO., LTD., FOREVER HOLDINGS LTD., OR FOSHAN SHUNDE YONGJIAN HOUSEWARES & HARDWARE CO., LTD. FOR THE PERIOD 02/03/2004 THROUGH 07/31/2005.

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 07-00123 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED ABOVE.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE MANUFACTURED OR EXPORTED BY

SINCE HARDWARE (GUANGZHOU) CO., LTD., FOREVER HOLDINGS LTD., OR FOSHAN SHUNDE YONGJIAN HOUSEWARES & HARDWARE CO LTD AND WHICH

WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 02/03/2004 THROUGH 07/31/2005. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

4. LIQUIDATION INSTRUCTIONS FOR ENTRIES AFFECTED BY THIS INJUNCTION HAVE NOT YET BEEN ISSUED.

5. EFFECTIVE IMMEDIATELY, CBP IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY ENTRIES SUBJECT TO THE ABOVE.

6. THE DEPARTMENT OF COMMERCE WAS SERVED WITH THE ABOVE REFERENCED INJUNCTION ON 04/18/2007. PURSUANT TO THE TERMS OF THE INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF 5:00 PM ON THE FIFTH BUSINESS DAY AFTER 04/18/2007.
