1. ON 05/04/2007, THE DEPARTMENT OF COMMERCE PUBLISHED IN THE FEDERAL REGISTER ITS FINAL RESULTS FOR THE SECTION 129 DETERMINATION ON STAINLESS STEEL BAR FROM FRANCE.

2. AS A RESULT OF COMMERCE'S DETERMINATION, THE CASH DEPOSIT RATE HAS BEEN REVISED FOR CERTAIN MANUFACTURER/EXPORTERS. THEREFORE, FOR SHIPMENTS OF STAINLESS BAR FROM FRANCE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 04/23/2007, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE

FOLLOWING MANUFACTURERS/EXPORTERS:

3. IF ANY ENTRIES OF THIS MERCHANDISE ARE EXPORTED BY A FIRM OTHER THAN THE MANUFACTURER, THEN THE FOLLOWING INSTRUCTIONS APPLY:

4. FOR ALL MANUFACTURERS/EXPORTERS OF STAINLESS STEEL BAR FROM FRANCE WITHOUT THEIR OWN RATE, THE CASH DEPOSIT RATE IS 35.92 PERCENT.

5. THESE CASH DEPOSIT REQUIREMENTS SHALL REMAIN IN EFFECT UNTIL FURTHER NOTICE. DO NOT LIQUIDATE ANY ENTRIES OF MERCHANDISE SUBJECT TO THIS SECTION 129 DETERMINATION UNTIL YOU RECEIVE SPECIFIC INSTRUCTIONS.
