RE: SCOPE RULING ON CVD ORDER ON CERTAIN HEAVY IRON CONSTRUCTION CASTINGS FROM BRAZIL (CASTINGS MADE OF GRAY OR DUCTILE CAST IRON ARE WITHIN SCOPE) (C-351-504)

1. ON MAY 3, 2007, IN RESPONSE TO A REQUEST BY THE DOMESTIC INDUSTRY, THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT IRON CONSTRUCTION CASTINGS MADE FROM EITHER GRAY OR DUCTILE CAST IRON ARE WITHIN THE SCOPE OF THE COUNTERVAILING DUTY ORDER ON CERTAIN HEAVY IRON CONSTRUCTION CASTINGS FROM BRAZIL (C-351-504).

2. BECAUSE THE UNITED STATES INTERNATIONAL TRADE COMMISSION

CONSIDERED IRON CONSTRUCTION CASTINGS MADE OF GRAY AND DUCTILE CAST IRON IN ITS ANALYSIS DURING THE ORIGINAL INVESTIGATION, COMMERCE FOUND GRAY AND DUCTILE IRON CONSTRUCTION CASTINGS TO BE WITHIN THE SCOPE OF THE ORDER. THE PRODUCT IS CLASSIFIED UNDER HTSUS NUMBERS 7325.10.00.

3. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF CERTAIN HEAVY IRON CONSTRUCTION CASTINGS FROM BRAZIL, INCLUDING IRON CONSTRUCTION CASTINGS MADE FROM EITHER GRAY OR DUCTILE CAST IRON, AND COLLECT CASH DEPOSITS OF ESTIMATED ANTIDUMPING DUTIES AT THE RATES IN EFFECT.
