ON 05/15/2007, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON STAINLESS STEEL WIRE ROD FROM SWEDEN (A-401-806), MANUFACTURED AND/OR EXPORTED BY FAGERSTA STAINLESS AB (A-401-806-001), IMPORTED BY FAGERSTA STAINLESS AB OR SANDVIK MATERIALS TECHNOLOGY, FOR THE PERIOD 09/01/2004 THROUGH 08/31/2005.

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE

NUMBER 07-153 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED ABOVE.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE PRODUCED AND/OR EXPORTED BY FAGERSTA STAINLESS AB (A-401-806-001), IMPORTED BY FAGERSTA STAINLESS AB OR SANDVIK MATERIALS TECHNOLOGY, AND WHICH WERE ENTERED,OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE

PERIOD 09/01/2004 THROUGH 08/31/2005. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

4. LIQUIDATION INSTRUCTIONS FOR ENTRIES AFFECTED BY THIS INJUNCTION HAVE NOT YET BEEN ISSUED.

5. EFFECTIVE IMMEDIATELY, CBP IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY ENTRIES SUBJECT TO THE ABOVE.

6. THE DEPARTMENT OF COMMERCE WAS SERVED WITH THE ABOVE REFERENCED INJUNCTION ON 05/16/2007. PURSUANT TO THE TERMS OF THE INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF 05/23/2007.
