1. ON 05\04\2007 (72 FR 25261), THE DEPARTMENT OF COMMERCE PUBLISHED IN THE FEDERAL REGISTER THE FINAL RESULTS FOR THE SECTION 129 DETERMINATION ON STAINLESS STEEL WIRE ROD FROM ITALY.

2. AS A RESULT OF COMMERCE'S DETERMINATION, THE CASH DEPOSIT RATES HAVE BEEN REVISED FOR CERTAIN MANUFACTURERS\EXPORTERS.

THEREFORE, FOR SHIPMENTS OF CERTAIN CUT-TO-LENGTH CARBON QUALITY

STEEL PLATE PRODUCTS FROM ITALY ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 04/23/2007, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING MANUFACTURERS\EXPORTERS:

3. IF ANY ENTRIES OF THIS MERCHANDISE ARE EXPORTED BY A FIRM OTHER THAN THE MANUFACTURER, THEN THE FOLLOWING INSTRUCTIONS APPLY:

4. FOR ALL MANUFACTURERS\EXPORTERS OF CERTAIN CUT-TO-LENGTH CARBON-QUALITY STEEL PLATE PRODUCTS FROM ITALY WITHOUT THEIR OWN RATE, THE CASH DEPOSIT RATE IS 7.64 PERCENT.

5. THESE CASH DEPOSIT REQUIREMENTS SHALL REMAIN IN EFFECT UNTIL FURTHER NOTICE. DO NOT LIQUIDATE ANY ENTRIES OF MERCHANDISE SUBJECT TO THIS SECTION 129 DETERMINATION UNTIL YOU RECEIVE SPECIFIC INSTRUCTIONS.
