TO THE ANTIDUMPING DUTY ORDER ON CARBAZOLE VIOLET PIGMENT 23 FROM THE PEOPLE'S REPUBLIC OF CHINA (PRC) FOR THE PERIOD OF JUNE 24, 2004, THROUGH NOVEMBER 30, 2005.
