THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (72 FR 37715) ON 07/11/2007 THE FINAL RESULTS AND FINAL RESCISSION, IN PART, OF ITS ADMINISTRATIVE REVIEW OF CERTAIN EXPORTERS SUBJECT TO THE ANTIDUMPING ORDER ON HONEY FROM THE PEOPLE'S REPUBLIC OF CHINA (PRC) FOR THE PERIOD 12/01/2004 THROUGH 11/30/2005.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES HAVE BEEN REVISED FOR A CERTAIN EXPORTER. THEREFORE, FOR SHIPMENTS OF

HONEY FROM THE PRC ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 07/11/2007, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING EXPORTER:
