ON 05/30/07, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON CERTAIN CORROSION-RESISTANT CARBON STEEL FLAT PRODUCTS FROM THE REPUBLIC OF KOREA A-580-816, MANUFACTURED AND EXPORTED BY DONGBU STEEL CO., LTD. (DONGBU) AND UNION STEEL MFG. CO., LTD. (UNION), FOR THE PERIOD 08/01/2004 THROUGH 07/31/2005.

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 07-00125 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED ABOVE.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE MANUFACTURED AND EXPORTED BY

DONGBU STEEL CO., LTD. (DONGBU) AND UNION STEEL MFG. CO., LTD. (UNION), AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 08/01/2004 THROUGH AND INCLUDING 07/31/2005. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

4. THIS INJUNCTION APPLIES TO THE LIQUIDATION INSTRUCTIONS COVERED BY MESSAGE NUMBER 7095210, DATED 04/05/2007, AND MESSAGE NUMBER 7144202, DATED 05/24/07.

5. EFFECTIVE IMMEDIATELY, CUSTOMS AND BORDER PROTECTION (CBP) IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY ENTRIES SUBJECT TO THE ABOVE.

6. THE DEPARTMENT OF COMMERCE WAS SERVED WITH THE ABOVE REFERENCED INJUNCTION ON 05/31/2007. PURSUANT TO THE TERMS OF THE INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF THE CLOSE OF BUSINESS ON 06/07/2007, THE FIFTH BUSINESS DAY AFTER THE DAY ON WHICH COPIES OF THIS ORDER WERE PERSONALLY SERVED BY PLAINTIFFS ON MS. ANN SEBASTIAN, IMPORT ADMINISTRATION.
