1. THIS IS A MODIFICATION OF MESSAGE NUMBER 6081204 DATED MARCH 22, 2006 OF PARAGRAPHS 2, 3, 5, AND 8. PARAGRAPHS 2, 3, 5, AND 8 OF MESSAGE NUMBER 6081204 ARE NO LONGER APPLICABLE AND HAVE BEEN REPLACED BY PARAGRAPHS 2, 3, 5, AND 8 OF THIS MESSAGE.

2. ON MARCH 14, 2005, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED INSTRUCTIONS ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON WOODEN

BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-890), EXPORTED BY DORBEST LIMITED, RUI FENG WOODWORK (DONGGUAN) CO., LTD. OR RUI FENG LUMBER DEVELOPMENT (SHENZHEN) CO., LTD, THAT WERE ENTERED ON OR AFTER JUNE 24, 2004, BUT EXCLUDING THE PERIOD BETWEEN DECEMBER 21, 2004, AND DECEMBER 27, 2004.

ON MARCH 15, 2006, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A MODIFICATION TO THE INJUNCTION ADDRESSED ABOVE, MODIFYING ONLY THE EFFECTIVE DATE OF THE INJUNCTION. IN ACCORDANCE WITH THE MARCH 15, 2006 MODIFICATION, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED INSTRUCTIONS ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-890), EXPORTED BY DORBEST LIMITED, RUI FENG WOODWORK (DONGGUAN) CO., LTD. OR RUI FENG LUMBER DEVELOPMENT (SHENZHEN) CO., LTD, THAT WERE ENTERED ON OR AFTER JANUARY 1, 2006.

3. ON MAY 16, 2007, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A SECOND MODIFICATION TO THE INJUNCTION ADDRESSED ABOVE, MODIFYING ONLY THE EFFECTIVE DATE OF THE INJUNCTION. IN ACCORDANCE WITH THE MAY 16, 2007 MODIFICATION, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED INSTRUCTIONS ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-890), EXPORTED BY DORBEST LIMITED, RUI FENG WOODWORK (DONGGUAN) CO., LTD. OR RUI FENG LUMBER DEVELOPMENT (SHENZHEN) CO., LTD, THAT WERE ENTERED ON OR AFTER JANUARY 1, 2007.

4. THIS AMENDED INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 05-CV-00003 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED ABOVE.

5. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE EXPORTED BY DORBEST LIMITED, RUI FENG WOODWORK (DONGGUAN) CO., LTD. OR RUI FENG LUMBER DEVELOPMENT (SHENZHEN) CO., LTD., AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER JANUARY

1, 2007. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

6. LIQUIDATION INSTRUCTIONS FOR ENTRIES OF SUBJECT MERCHANDISE WHICH WERE EXPORTED BY DORBEST LIMITED, RUI FENG WOODWORK (DONGGUAN) CO., LTD. AND RUI FENG LUMBER DEVELOPMENT (SHENZHEN) CO., LTD, THAT WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD JUNE 24, 2004 THROUGH DECEMBER 31, 2006, HAVE NOT YET BEEN ISSUED. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

7. THESE INSTRUCTIONS TAKE EFFECT IMMEDIATELY.

8. THE DEPARTMENT OF COMMERCE WAS SERVED WITH THE ABOVE REFERENCED INJUNCTION ON MAY 17, 2007. PURSUANT TO THE TERMS OF THE INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF 5:00 PM ON THE FIFTH BUSINESS DAY AFTER THE DAY UPON WHICH COPIES OF THIS ORDER ARE PERSONALLY SERVED TO THE APO DOCKET CENTER AT THE DEPARTMENT OF COMMERCE.
