RE: SCOPE RULING AND LIQUIDATION ON WOODEN BEDROOM FURNITURE FROM CHINA (A-570-890)

1. ON 06/11/2007, IN RESPONSE TO A REQUEST BY TARGET CORPORATION, THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT FIVE ITEMS (BENCH ITEM NUMBER 249-10-0011, COMPUTER CART ITEM NUMBER 249-10-0010, BOOKCASE ITEM NUMBER 249-10-0008, MODULAR ROOM DIVIDER ITEM NUMBER 249-10-0015 AND DESK NUMBER 249-10-0007) IN THE TARGET CORPORATION'S MANHATTAN COLLECTION ARE NOT WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-890).

2. THE COMMERCE DEPARTMENT DETERMINED THAT FIVE ITEMS (BENCH ITEM NUMBER 249-10-0011, COMPUTER CART ITEM NUMBER 249-10-0010, BOOKCASE ITEM NUMBER 249-10-0008, MODULAR ROOM DIVIDER ITEM NUMBER 249-10-0015 AND DESK NUMBER 249-10-0007) IN THE TARGET CORPORATION'S MANHATTAN COLLECTION DO NOT MEET THE DESCRIPTION OF MERCHANDISE COVERED BY THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA OR ARE SPECIFICALLY EXCLUDED BY THE ORDER. THEREFORE, THE FIVE ITEMS (BENCH ITEM NUMBER 249-10-0011, COMPUTER CART ITEM NUMBER 249-10-0010, BOOKCASE ITEM NUMBER 249-10-0008, MODULAR ROOM DIVIDER ITEM NUMBER 249-10-0015 AND DESK NUMBER 249-10-0007) IN THE TARGET CORPORATION'S MANHATTAN COLLECTION ARE NOT WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA.

3. EFFECTIVE 06/11/2007, TERMINATE SUSPENSION AND LIQUIDATE ALL UNLIQUIDATED ENTRIES OF THE MERCHANDISE DESCRIBED ABOVE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 06/24/2004 OF THE FIVE ITEMS (BENCH ITEM NUMBER 249-10-0011, COMPUTER CART ITEM NUMBER 249-10-0010, BOOKCASE ITEM NUMBER 249-10-0008, MODULAR ROOM DIVIDER ITEM NUMBER 249-10-0015 AND DESK NUMBER 249-10-0007) IN THE TARGET CORPORATION'S MANHATTAN COLLECTION LISTED ABOVE.

4. REFUND ANY CASH DEPOSITS WITH INTEREST AND RELEASE ANY BONDS RELATING TO THE FIVE ITEMS (BENCH ITEM NUMBER 249-10-0011, COMPUTER CART ITEM NUMBER 249-10-0010, BOOKCASE ITEM NUMBER 249-10-0008, MODULAR ROOM DIVIDER ITEM NUMBER 249-10-0015 AND DESK NUMBER 249-10-0007) IN THE TARGET CORPORATION'S MANHATTAN COLLECTION LISTED ABOVE.

5. THE ASSESSMENT OF ANTIDUMPING DUTIES BY CUSTOMS AND BORDER PROTECTION ON ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930. SECTION 778 REQUIRES THAT CBP PAY INTEREST ON OVERPAYMENTS, OR ASSESS INTEREST ON UNDER PAYMENTS, OF THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED ANTIDUMPING DUTIES. THE INTEREST PROVISIONS ARE NOT

APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED ANTIDUMPING DUTIES BEFORE THE DATE OF PUBLICATION OF THE ANTIDUMPING DUTY ORDER WHICH IS JANUARY 4, 2005. INTEREST SHALL BE CALCULATED FROM THE DATE PAYMENT OF ESTIMATED ANTIDUMPING DUTIES IS REQUIRED THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.

6. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF WOODEN BEDROOM FURNITURE SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA.
