THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER 72 FR 51787 ON 09/11/2007 THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF CERTAIN EXPORTERS SUBJECT TO THE ANTIDUMPING ORDER ON HEAVY FORGED HAND TOOLS, FINISHED OR UNFINISHED, WITH OR WITHOUT HANDLES (PICKS AND MATTOCKS) FROM THE PEOPLE'S REPUBLIC OF CHINA FOR THE PERIOD 02/01/2005 THROUGH 01/31/2006.

NOTE THAT THE DEPARTMENT OF COMMERCE CASE NUMBER FOR HEAVY

FORGED HAND TOOLS, FINISHED OR UNFINISHED, WITH OR WITHOUT HANDLES, IS A-570-803; THIS COMMERCE CASE NUMBER A-570-803 INCLUDES "HAMMERS AND SLEDGES," "BARS AND WEDGES," "PICKS AND MATTOCKS," AND "AXES AND ADZES." THE CBP CASE NUMBER A-570-203 COVERS JUST "PICKS AND MATTOCKS."

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES HAVE BEEN REVISED FOR CERTAIN EXPORTERS. THEREFORE, FOR SHIPMENTS OF HEAVY FORGED HAND TOOLS, FINISHED OR UNFINISHED, WITH OR WITHOUT HANDLES (PICKS AND MATTOCKS) FROM THE PEOPLE'S REPUBLIC OF CHINA ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 09/11/2007, THE REQUIRED CASH DEPOSIT RATES FOR THE FOLLOWING EXPORTERS THAT DO NOT HAVE SEPARATE RATE STATUS, BUT WHICH HAVE FUNCTIONING TEN-DIGIT CASE NUMBERS, ARE AS FOLLOWS:

4. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS FOR THE NEXT ADMINISTRATIVE REVIEW. DO NOT LIQUIDATE ANY ENTRIES COVERED BY THIS REVIEW UNTIL YOU HAVE RECEIVED LIQUIDATION INSTRUCTIONS.
