1. ON 09/06/2007, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A
PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES
WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON WOODEN
BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA A-570-890,
PRODUCED AND/OR EXPORTED BY MACAU YOUCHENG TRADING CO. AND
ZHONGSHAN YOUCHENG WOODEN ARTS & CRAFTS CO., LTD. FOR THE PERIOD
06/24/2004 THROUGH 12/20/2004 AND 12/28/2004 THROUGH 12/31/2005.

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 07-00322 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED ABOVE.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE PRODUCED AND/OR EXPORTED BY MACAU YOUCHENG TRADING CO. AND ZHONGSHAN YOUCHENG WOODEN ARTS & CRAFTS CO., LTD. AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 06/24/2004 THROUGH 12/20/2004 AND 12/28/2004 THROUGH 12/31/2005. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

4. LIQUIDATION INSTRUCTIONS FOR ENTRIES AFFECTED BY THIS INJUNCTION HAVE NOT YET BEEN ISSUED.

5. EFFECTIVE IMMEDIATELY, CBP IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY ENTRIES SUBJECT TO THE ABOVE.

6. THE DEPARTMENT OF COMMERCE WAS SERVED WITH THE ABOVE REFERENCED INJUNCTION ON 09/10/2007 PURSUANT TO THE TERMS OF THE INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF THE FIFTH BUSINESS DAY AFTER COPIES OF THIS ORDER WERE SERVED TO THE APO DOCKET CENTER.
