ON 09/24/2007, IN RESPONSE TO A REQUEST BY WEDDING BRAND INVESTORS ("WEDDING BRAND"), THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT THE FOLLOWING CANDLES ARE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-504):

2. THE DEPARTMENT OF COMMERCE DETERMINED THAT WEDDING BRAND'S CANDLES DO NOT QUALIFY FOR EXCLUSION FROM THE SCOPE OF THE ANTIDUMPING ORDER COVERING PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA PURSUANT TO THE NOVELTY CANDLE EXCEPTION.

3. EFFECTIVE 09/24/2007, CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA, INCLUDING WEDDING BRAND'S CANDLES LISTED ABOVE, SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA.
