THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (72 FR 45221) ON 08/13/2007 THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF CERTAIN MANUFACTURERS/EXPORTERS SUBJECT TO THE ANTIDUMPING DUTY ORDER ON STAINLESS STEEL FLANGES FROM INDIA FOR THE PERIOD 02/01/2005 THROUGH 01/31/2006.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES HAVE BEEN REVISED FOR CERTAIN MANUFACTURERS/EXPORTERS. THEREFORE,

FOR SHIPMENTS OF STAINLESS STEEL FLANGES FROM INDIA ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 08/13/2007, THE REQUIRED CASH DEPOSITS HAVE BEEN REVISED FOR THE FOLLOWING MANUFACTURERS/EXPORTERS:

ECHJAY FORGINGS, PVT. LTD. A-533-809-010 0.00 PERCENT

ROLLWELL FORGE, LTD. A-533-809-019 48.68 PERCENT

3. IF ANY ENTRIES OF THIS MERCHANDISE ARE EXPORTED BY A FIRM OTHER THAN THE MANUFACTURER, THEN THE FOLLOWING INSTRUCTIONS APPLY:

A. IF THE EXPORTER OF THE SUBJECT MERCHANDISE HAS ITS OWN RATE, USE THE EXPORTER'S RATE FOR DETERMINING THE CASH DEPOSIT RATE.

4. FOR ALL MANUFACTURERS/EXPORTERS OF STAINLESS STEEL FLANGES FROM INDIA WITHOUT THEIR OWN RATE, THE CASH DEPOSIT RATE IS 162.14 PERCENT.

5. THESE CASH DEPOSIT REQUIREMENTS SHALL REMAIN IN EFFECT UNTIL FURTHER NOTICE. DO NOT LIQUIDATE ANY ENTRIES OF MERCHANDISE INCLUDED IN THIS ADMINISTRATIVE REVIEW UNTIL ASSESSMENT INSTRUCTIONS ARE RECEIVED.
