1. ON 10/16/2007, THE U.S. COURT OF INTERNATIONAL TRADE
ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF
CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY
ORDER ON BALL BEARINGS AND PARTS THEREOF (BBS) FROM JAPAN
(A-588-201-005) WHICH WERE PRODUCED AND/OR EXPORTED BY JTEKT
CORPORATION (FORMERLY KNOWN AS KOYO SEIKO CO., LTD.) (JTEKT),
IMPORTED BY OR SOLD TO (AS INDICATED ON THE COMMERCIAL INVOICE

OR CUSTOMS DOCUMENTATION) KOYO CORPORATION OF U.S.A.(KCU), AND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 05/01/2005 THROUGH 04/30/2006.

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 07-00377 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED ABOVE.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE PRODUCED AND/OR EXPORTED BY JTEKT, IMPORTED BY OR SOLD TO (AS INDICATED ON THE COMMERCIAL INVOICE OR CUSTOMS DOCUMENTATION) KCU, AND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 05/01/2005 THROUGH 04/30/2006. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

4. LIQUIDATION INSTRUCTIONS FOR ENTRIES AFFECTED BY THIS INJUNCTION HAVE NOT YET BEEN ISSUED.

5. EFFECTIVE IMMEDIATELY, U.S. CUSTOMS AND BORDER PROTECTION (CBP) IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY ENTRIES SUBJECT TO THE ABOVE.

6. THE DEPARTMENT OF COMMERCE WAS SERVED WITH THE ABOVE-REFERENCED INJUNCTION ON 10/17/2007. PURSUANT TO THE TERMS OF THE INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF 5:00 P.M. ON THE FIFTH BUSINESS DAY AFTER THE DAY ON WHICH COPIES OF THIS ORDER ARE PERSONALLY SERVED TO THE APO DOCKET CENTER AT COMMERCE.
