THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (72 FR 58809) ON 10/17/2007 THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF CERTAIN EXPORTERS SUBJECT TO THE ANTIDUMPING DUTY ORDER ON GLYCINE FROM THE PEOPLE'S REPUBLIC OF CHINA (PRC) FOR THE PERIOD 03/01/2005 THROUGH 02/28/2006.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES HAVE BEEN REVISED FOR CERTAIN EXPORTERS. THEREFORE, FOR SHIPMENTS OF GLYCINE FROM THE PEOPLE'S REPUBLIC OF CHINA ENTERED, OR

WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 10/17/2007, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING EXPORTERS:

4. THESE CASH DEPOSIT REQUIREMENTS SHALL REMAIN IN EFFECT UNTIL FURTHER NOTICE. DO NOT LIQUIDATE ANY ENTRIES OF MERCHANDISE INCLUDED IN THIS ADMINISTRATIVE REVIEW UNTIL ASSESSMENT INSTRUCTIONS ARE RECEIVED.
