1. ON OCTOBER 18, 2007, THE U.S. COURT OF INTERNATIONAL TRADE  
ISSUED AN AMENDED PRELIMINARY INJUNCTION ENJOINING LIQUIDATION  
OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY  
ORDER ON STAINLESS STEEL BAR FROM INDIA (A-533-810),  
MANUFACTURED AND/OR EXPORTED BY BHANSALI BRIGHT BARS PVT. LTD.  
(A-533-810-011), VENUS WIRE INDUSTRIES PVT. LTD. AND PRECISION  
METALS (A-533-810-012), ISIBARS LIMITED (A-533-810-007), GRAND  
FOUNDRY, LTD. (A-533-810-001), FACOR STEELS, LTD. AND/OR FERRO

ALLOYS CORPORATION LIMITED (A-533-810-005), AND MUKAND LTD.  
(A-533-810-002) FOR THE PERIOD 02/01/2005 THROUGH 01/31/2006.

2. THIS AMENDED INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 07-00366 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED ABOVE. NOTE THAT THE DEPARTMENT HAS ALREADY ISSUED A PRELIMINARY INJUNCTION FOR THIS CASE ON OCTOBER 15, 2007 (MESSAGE NUMBER 7288201).

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE PRODUCED AND/OR EXPORTED BY BHANSALI BRIGHT BARS PVT. LTD. (A-533-810-011), VENUS WIRE INDUSTRIES PVT. LTD. AND PRECISION METALS (A-533-810-012), ISIBARS LIMITED (A-533-810-007), GRAND FOUNDRY, LTD. (A-533-810-001), FACOR STEELS, LTD. AND/OR FERRO ALLOYS CORPORATION LIMITED (A-533-810-005), AND MUKAND LTD. (A-533-810-002) AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 02/01/2005 THROUGH 01/31/2006. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

4. LIQUIDATION INSTRUCTIONS FOR ENTRIES AFFECTED BY THIS INJUNCTION HAVE NOT YET BEEN ISSUED.

5. EFFECTIVE IMMEDIATELY, CBP IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY ENTRIES SUBJECT TO THE ABOVE.

6. THE DEPARTMENT OF COMMERCE WAS SERVED WITH THE ABOVE REFERENCED INJUNCTION ON OCTOBER 23, 2007. PURSUANT TO THE TERMS OF THE INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF THE FIFTH BUSINESS DAY AFTER THE DATE ON WHICH THIS ORDER IS PERSONALLY SERVED BY HAND DELIVERY BY PLAINTIFFS, WHICH IS OCTOBER 30, 2007.
